Entry date and times: First Saturday after Labor Day 7:30 AM to 9:00 AM

- 1. THERE ARE NO ENTRY FEES
- 2. Only products entered in the Fair may be displayed during the Fair
- 3. Entries: Fill out 1 entry form per item. Ribbons will be awarded
- 4. Premium/award will be given to the adult male, adult female, junior boy, junior girl with the most points based on each ribbon earned during judging
  3 points = Blue Ribbon (1st place) 2 points = Red Ribbon (2nd place) 1 point = White Ribbon (3rd place)

Community Fair Exhibits accepted in all of the following Categories:

- Land Products (Plates will be furnished for exhibits)
- Eggs display 1 dozen
- Fruit & Berries display 1 dozen
- Garden Herbs display 4 sprigs
- Honey Strained, in 1 pound jars
- Nuts display 1 dozen
- Potatoes display 4 to 6
- Vegetables display varies by size

Large (i.e. squash) display 1

Medium (i.e. peppers) display 3

Small (i.e. beans) display 12

- Floral (Entries to be shown with their own attached leaves) The Fair will furnish containers.
- Cut Flowers bring 1 cut stem or 1 flower
- Miniature Cut Flowers bring 3 cut stems or 3 flowers
- Potted Plants no hanging baskets (not open to commercial growers)
- Food Preservation preserved within 1 year of September current year. All entries must be in Brand Name mason or ball canning jars with new rings. All canned exhibits must be processed according to current standards.
- $\circ$  Canned Fruit ¼ pint, ½ pint, 1 pint, or 1 quart. Fruit juices in ½ gallon.
- ∘ Canned Vegetables ¼ pint, ½ pint, 1 pint, or 1 quart.
- ∘ Pickles, Relish & Sauces ¼ pint, ½ pint, 1 pint, or 1 quart.
- $\circ$  Meats  $\frac{1}{4}$  pint,  $\frac{1}{2}$  pint, 1 pint, or 1 quart. Do not use quart for Salmon or Tuna
- $\circ$  Jellies  $\frac{1}{4}$  pint,  $\frac{1}{2}$  pint, 1 pint Mason Jars
- $\circ$  Preserves  $1\!\!/_{\!\!4}$  pint,  $1\!\!/_{\!\!2}$  pint, 1 pint Mason Jars. Small pieces of fruit in thick syrup.
- Marmalade ¼ pint, ½ pint, 1 pint Mason Jars. Fruit with Citrus Fruit added.
- $\circ$  Butters and Jams  $\frac{1}{4}$  pint,  $\frac{1}{2}$  pint, 1 pint Mason Jars
- $\circ$  Dried Fruit ½ cup in reseal able bag
- $\circ$  Dried Vegetables  $\frac{1}{2}$  cup in reseal able bag
- $\circ$  Dried Meat / Jerky 6 slices or ½ cup chips in reseal able bag
- $\circ$  Fruit Leather 6 inch roll in snack size reseal able bag
- $\circ$  Dried Herbs and Spices  $\frac{1}{2}$  cup in snack size reseal able bag
- Flavored Vinegar

- Baking and Candy
- Yeast Breads standard size loaves and mini loaves accepted
- Quick Breads standard size loaves and mini loaves accepted
- Cookies 4 cookies per entry
- Candy 5 pieces per entry
- Alternative Preparations Gluten Free and/or Sugar Free or any other entry that addresses special dietary needs. – Include recipe
- Cakes display on disposable board or foil wrapped cardboard. Frosting optional.
   Bring full cake or 4 cupcakes.
- Pies 1 whole pie in a disposable pie pan. No Meat Pies.
- Decorated Cakes may be over Styrofoam or other form.
- Textiles all entries must be clean and free from odor and pet hair.
- · Linens judged on construction only
- Dolls & Toys
- Knitting
- Crochet
- Artistic Handiwork
- Ouilts
- Laces, Embroidery, Tatting
- Garments Woven Fabric
- Garments Knit Fabric
- Rugs
- Weaving
- Hand-spun Yarn
- Art All artwork must have been completed within the last 3 years. No entries submitted previously will be accepted.
- Antiques to be judged based on uniqueness and conditions.

## JUDGING POLICIES

- 1. **All entries** will be judged on the American System (Rank System) meaning entries will be marked 1st, 2nd, 3rd place.
- 2. Any names of exhibitors on entries must be covered for the judging process.
- 3. Department Coordinators, under the direction of the Event Coordinator, shall have full charge of their Department, and exhibitors must follow their direction relating to placing of exhibits, showing,
- 4. It is the duty of the Coordinator to make such correction as they deem necessary if it is ascertained that an entry is entered in a division or class in which it does not properly belong or fails to follow published rules/guidelines.
- 5. The Coordinators shall see that awards are correctly entered on the judging materials, checking all numbers and having each judge and clerk sign off on the results, and attaching their signature of approval and returning results to the Fair Coordinator.
- 6. Coordinators may counsel the judges on leniency of rules as the Community Fair is interested in participation and inclusion more than absolute adherence to the rules.
- 7. The following guidelines are to provide you suggested items, this list is not inclusive to what you can enter merely suggestions.

It is expected that ALL EXHIBITORS at the Fair conduct themselves with honesty, good sportsmanship and in a professional manner. Their conduct in the competitive environment shall always reflect the highest standards of honor and dignity.
