## MISSION STATEMENT

The Grange provides opportunities for individuals and families to develop to their highest potential in order to build stronger communities and states, as well as a stronger nation.

## 144 YEARS OF GRANGE COMMUNITY CONNECTIONS

The Washington County Agricultural Society was responsible for the county fair for many years after holding the first county fair in 1864 at Forest Grove. With the responsibility of starting and managing the county fair came praise and criticism.

The fair would showcase farm, home, art, craft, music, livestock, racing, game of chance, gambling and of course liquor. The fair would draw a large crowd of diversified individuals and the conservative members of the community wanted to see a community fair focused more on healthy completion of farm and home goods than on horse racing and gambling. In 1875 the Agricultural Society had a heated discussion regarding the sale of alcohol on the fairgrounds. By a vote of 109 to 102 the society prohibited the sale of alcohol on the fair grounds that year.

The Washington County Fair predates the Grange by several years. However, one can find charter members of the Grange in the agricultural society, most notably Robert Imbrie, charter member of West Union Grange, 1873.

In short, after several years of bringing the county fair to the public, the agricultural society backed out and by 1918 the Granges of Washington County shouldered a large responsibility for the county fair. Well rehearsed in running community fairs (Scholls, Tigard, Leedy, Washington and Green Mountain to name a few who held their own community fairs). The Granges held their presence at the Washington County Fair until 2018. Of note, in 1983, on the floor of the Pomona Grange was the discussion of selling or leasing the fairgrounds. A discussion of developing the present fair grounds into a major cultural recreational complex was also entertained. Cost and management weighed heavy on the minds of Grange members. Washington County Fair was in part a good healthy event for the community that stretched generations.

In the fall of 1984, it was announced the fair would have a new superintendent for the fair booths and would welcome any suggestions or help from the Granges. This is the same year the hotel tax measure to raise the tax by 2% was on the ballot; the county fair would see half of

the 2% increase. Pomona Grange went on record in support of the measure.

The Granges of Washington County have a long history in support of the county fair and the fairgrounds. It is not possible to make a detailed account in such short space. However, I do wish to encourage everyone to write your county commissioner. Let them know you support recognition of the Grange in the new exhibit hall.

Leedy Grange #339 - **Congratulations to Leedy Grange** - They won the Ice Cream Social for District 3 for having the largest percentage in membership gain.

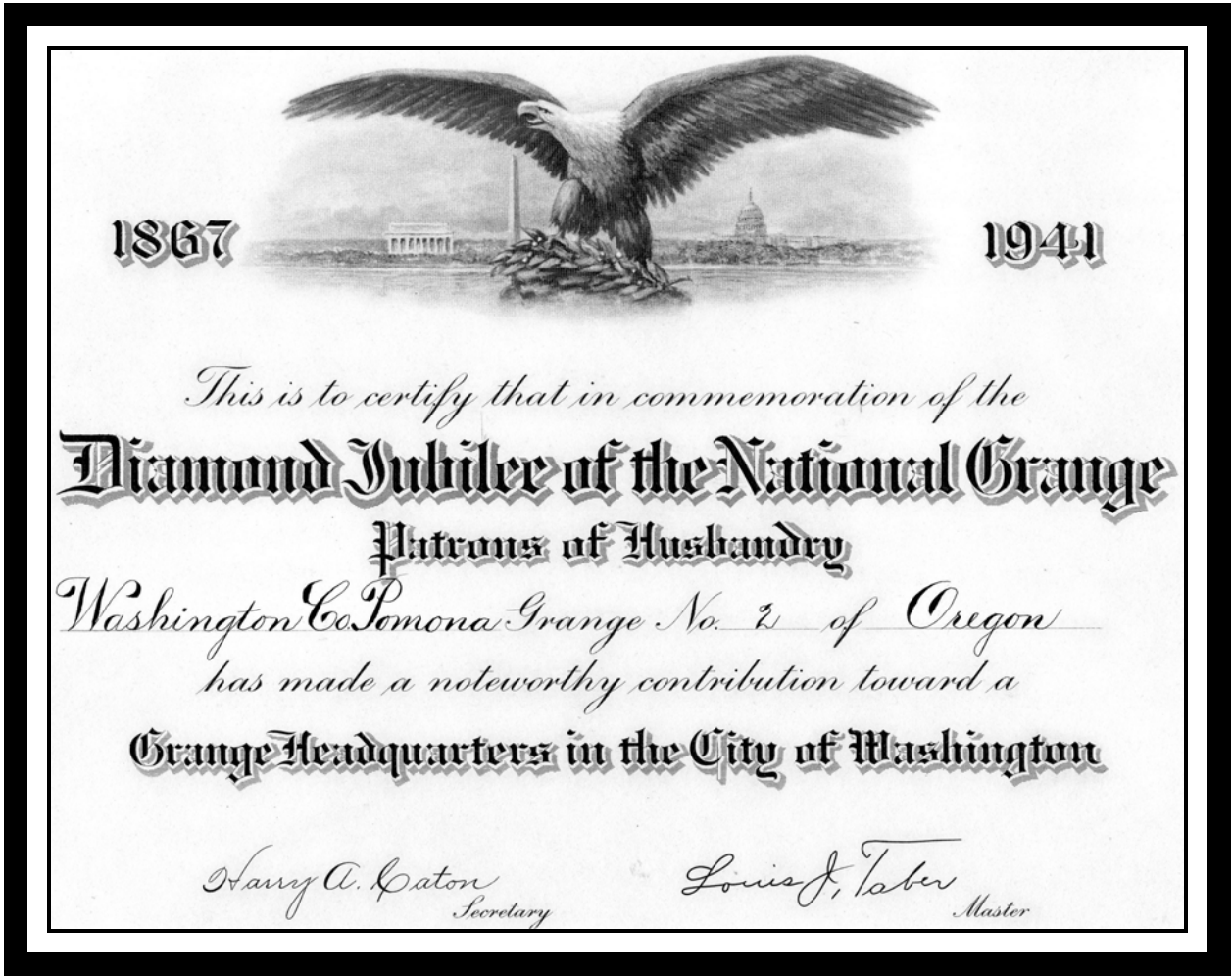
