Grange is committed to voluntary, incentivebased climate solutions

The National Grange is a member of the Food and Agriculture Climate Alliance, which is comprised of more than 80 organizations representing farmers, forest owners, agribusinesses, manufacturers, sportsmen, state governments, and environmental advocates. As Congress further debates and negotiates the size of the current budget reconciliation package, FACA is urging Congress to prioritize

the climate-smart agriculture and forestry initiatives contained in the package.

We support investments in voluntary, incentive-based, science-based climate and conservation programs to, 1) foster carbon capture and storage on farms, ranches and forest lands, 2) reduce greenhouse gas emissions, and 3) provide many other additional environmental benefits such as cleaner water, regenerated soils and improved wildlife habitat.

Chaplain, Anna Seuberth:

As you may or may not know my sister, Mary Tress, a fellow Granger died last month of an aggressive form of Breast Cancer. October is Breast Cancer Awareness Month. Per the American Cancer Society, cancer starts when cells begin to grow out of control. The cells usually form a tumor that can be seen on X-ray or felt as a lump as small as 1/2 - 3/4 of an inch. Rapid growth tumors can double in size every 25 days. It can spread when cells get into the blood or lymph system and get carried to other parts of the body. There is 1 in 8 chance a women will develop breast cancer in the US. Every 2 minutes a woman is diagnosed with it. In Delaware there will be an estimated 7,090 new cases. 1 in 39 women will die per year in the US. Breast Cancer is rare in men, only 1 % will get it. The American Cancer Society recommends that women receive an annual Mammogram after the age of 45. Breast Cancer impacts all of us. Please share your support in your own way....
